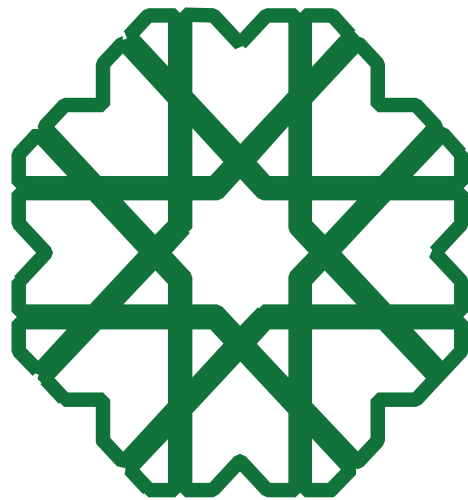

DATA PROTECTION ACT 2018
CONSENT FORM



The Data Protection Act 2018 controls how your personal information is used by organisations, businesses or the government. The Data Protection Act 2018 is the UK's implementation of the General Data Protection Regulation (GDPR). They must make sure the information is: used fairly, lawfully and transparently.

In order to comply with the Data Protection Act 2018, Oasis Crescent (UK) Limited ("OCUK") including its subsidiaries Oasis Crescent Wealth (UK) Limited ("OCW UK") and Oasis Global Management Company (Ireland) Limited ("OGMCI"), which are hereinafter individually and collectively referred to as "the company", wish to obtain your informed consent about the data we may hold about you.

INFORMATION WE COLLECT AND HOW WE USE IT

Owing to the relationship with you, we will collect your personal information, such as your name, identification number, address, phone number and email address as well as other non-public information including your financial, beneficiary and dependents information for the applicable product or service ("Personal Information"). All personal information is processed on our behalf by our subsidiaries and partner companies as well as external service providers, where necessary.
